Resolution 05-13

This resolution rescinds RESOLUTION NO. 2007-02

Purpose: The purpose of this resolution is twofold;

- 1. To rescind RESOLUTION NO. 2007-02 regarding enforcement of protective covenants based upon a complaint in Division 19
- 2. Establish the Lake Cushman Maintenance Company's (LCMC) position with regard to enforcing provisions contained within each Division's applicable protective covenants.

Whereas: Pursuant to its Articles of Incorporation, The LCMC has authority and the responsibility for the enforcement of provisions in applicable protective covenants; and

- Whereas: The Articles of Incorporation authorize LCMC to exercise <u>discretion</u> in using powers of control, interpretation, construction, consent, decision, determination, modification, amendment, cancellation, annulment, and/or enforcement of covenants; and
- Whereas: Disputes that arise between lessees wherein one or more lessee(s) is seeking enforcement action of restrictive covenants; and
- **Whereas:** Individual lessees have legal standing and ability to bring a private enforcement action to enforce restrictive covenants that uniquely affect their respective property; and
- **Whereas:** The Board determines that disputes between lessees do not sufficiently impact the overall community that would justify the investment of community financial and other resources in what becomes a private dispute between lessees; and
- Whereas: The Board realizes that private disputes are unique to the dispute's particular set of circumstances; now therefore be it

Resolved: The Board retains the right to not intervene in private disputes when deemed it is in LCMC's best interest.
