Resolution 01-14 Licensed Drivers on LCMC Property Revised 6/14/14

The Lake Cushman Maintenance Company is referred to herein as the LCMC

- **Purpose:** The purpose of this resolution is to create a safer environment for those using LCMC roads.
- Whereas: LCMC has received considerable complaints about under aged persons operating golf carts, ATVs, and other small engine vehicles on LCMC roads in an unsafe manner; and;
- Whereas: It is to the benefit of the community that such motorized vehicles on its roads be operated in a manner that is safe for the operator and others on the roads; be it;
- Resolved: That only licensed drivers and those unlicensed drivers accompanied by licensed drivers may operate motorized vehicles mentioned above on LCMC roads. Additionally, LCMC Security is authorized to issue citations for violation of this rule, and the fine shall be \$100.00. EXCEPTION: Street legal vehicles (e.g., cars, trucks, busses, motorcycles, etc.) are outside the scope of this resolution, as each driver of these types of vehicles must possess a valid driver's license.
